Section 4: First aid measures

4.1 Description of first aid measures

Skin contact: wash the contaminated skin with plenty of water. Consult a doctor if disturbing symptoms appear.

<u>Eye contact</u>: wash the contaminated eye with plenty of water for 10-15 minutes. Keep eyelids wide open. Avoid strong stream of water – risk of damage of the cornea. Consult an ophthalmologist if disturbing symptoms appear.

<u>Inhalation:</u> remove the victim to fresh air. Keep victim warm and calm. Consult a doctor if disturbing symptoms appear.

4.2 Most import ant symptoms and effects, both acute and delayed

Skin contact: prolonged contact may cause redness, burning sensation, drying, cracking of the skin.

Eye contact: possible redness, tearing, burning, temporary irritation.

Ingestion: may cause nausea, vomiting, abdominal pains.

Inhalation: exposure to high concentrations of product vapours may lead to headaches, nausea.

4.3 Indication of any immediate medical attention and special treatment needed

Section 5: Firefighting measures

5.1 Extinguishing media

Suitable extinguishing media: adapt the extinguishing media to surrounding materials.

5.2 Special hazards arising from the substance or mixture

5.3 Advice for firefighters

Personal protection typical in case of fire. Do not stay in the fire zone without self-contained breathing apparatus and protective clothing resistant to chemicals. Limit the access for the outsiders into the breakdown area, until the suitable cleaning operations are completed. In case of a large release, isolate the exposed area. Immediately wipe spilled product – may produce extremely slippery surfaces.

7.1 Precautions for safe handling

Handle in accordance with good occupational hygiene and safety practices. Avoid eyes and skin contamination. Wash hands carefully before breaks and after work. Do not inhale product vapours. Ensure adequate ventilation of the area in which product is stored and used. Keep the unused containers tightly closed.
